## VENDOR CONTRACT & RULES AND REGULATIONS

This agreement must be signed and returned with application and payment

All vendors must have original merchandise (handmade, original imported or domestic items) submit (3) pictures, slides or e-mail photo.

Completed signed applications must be received prior to show date. Vendor indemnifies artworkschicago from any liability of product sales. Vendor are not allowed to sell illegal items.

Advance payment required. No eating in booth no exceptions.

Vendor must keep area clean and neat at all times. All garbage in your area is your responsibility and must be removed at all times during and after event.

No booth sharing or changing of booth space allowed.

The assignment of exhibit spaces shall be solely at the discretion of the promoter.

Exhibitors must wear i.d. pins, locator cards, supplied by promoter at all times.

No hand-written signs, no signage may be attached to any venue fixtures, poles, etc.

No display of discount sale signage allowed all signage must be printed and approved.

Vendor must supply tables and table coverings and/or skirts.

All vendors must load-in at prescribed time-no exceptions. Times will be sent to you on acceptance of your application.

All items must remain inside booths at all times (2) racks per booth.

All dates are subject to change. All fees are -non-refundable

Special 10% discount to vendors that refer additional vendors.

Vendor discount based on acceptance.

All outdoor events require a clean 10x10 white tent or pop-ups no exceptions. All tents must be weighted down on all sides 40lbs each side of tent. No bungle cords tents not weighed are not excepted to show with no refunds. All shows subject to change of date. All vendor fees are non-refundable.

Vendors are responsible for opening on time. Vendors will be notified of opening and closing times by promoter. There will be a \$25.00 fine for late openings. No exceptions. Fine must be paid same day or vendor will be expelled from event.

Vendor accepts and agrees to pay in full booth fee and waives all rights with no contest to judgement in this matter.

Vendor agrees to follow all rules and regulations of the promoter, staff and venue management at all times. Promoter reserves the right to terminate this agreement if rules are not followed with no refunds or at any time for any reason.

Vendor indemnifies promoter of any and all damages to products, equipment, property and accidents that may cause any injury or damage to vendor or any other person and/or property at this event.
